## **PART 1 – ADMINISTRATION**

- 1.1** These Rules and Regulations of the Sunshine Coast Rod and Gun Club are published on the Club website at [scrgc.ca](http://scrgc.ca).
- 1.2** In a case of conflict between these Rules and Regulations and any other directives such as signage, these Rules and Regulations shall prevail.
- 1.3** All club members are responsible for familiarizing themselves with the Rules and Regulations.
- 1.4** Members agree to abide by the Rules and Regulations.
- 1.5** Under Bylaw 14.2, the rules and regulations may be altered by the board, subject to the approval of the general meeting.
- 1.6** Under Bylaw 14.2.1, the rules and regulations may also be altered by the general meeting.
- 1.7** Hours of operation are posted on the Club website.
- 1.8** The outdoor ranges are closed on Remembrance Day and Christmas Day.
- 1.9** The date(s) and time(s) of club meetings are posted on the Club website.
- 1.10** The minutes of Club meetings are posted on the Club website.
- 1.11** Membership application information is posted on the Club website. Online membership applications can be processed there.
- 1.12** New and renewing members must sign a Waiver of Claims, Release from Liability and Assumption of Risk which forms an integral part of the membership application.
- 1.13** For those members wishing to display their firearms in the Clubhouse, a designated safe area is provided. All safety rules apply. All firearms must be cased when being brought to and removed from the safe area.
- 1.14** Members should be aware that recording security cameras may be in operation anywhere on either the lower Club property, inside the Clubhouse or the Pinecone property.

## **PART 2 – GUEST POLICY**

- 2.1** A member may bring one or more guests to the Club and must accept full responsibility for each guest.
- 2.2** A guest may use a shooting range provided the accompanying member agrees:
  - a) to provide direct and immediate supervision of the guest;
  - b) to provide direct and immediate supervision to only one guest at

- any given time;
- c) to ensure the guest abides by the rules and regulations;
- d) to ensure the guest completes the guest chit and pays any applicable range use fees as prescribed on the SCRGC website;
- e) to ensure the guest does not use Club shooting ranges more than three times, after which the guest must become a member to continue using any range.

### **PART 3 – RANGE ACCESS**

- 3.1** Every member bringing a firearm onto Club property at the Lower Ranges, or Club License of Occupation at the Upper Ranges, must have in their possession the following valid documentation, issued to that member:
- a) Numbered badge.
  - b) Club membership card.
  - c) Firearms license.
  - d) Registration certificate, if applicable.
  - e) Authorization to transport, if applicable.
- 3.3** The member's numbered badge must be worn and visible while on or using any range.
- 3.4** For clarity, the definition of a "range" is the specifically the area where shooting takes place and includes:
- a) the firing line;
  - b) the area behind the firing line used for storage, assembly and observation of the firing line;
  - c) the entire target area in front of the firing line.
- 3.5** A "range" does not include areas such as parking lots, camping areas, access roads, the Clubhouse or any other land included in the Club property or the License of Occupation at the Pinecone property.

#### **Security – Lower Ranges**

- 3.2** The lower ranges include the Indoor Range, the Pistol Range, the Rifle Range, Skeet and Trap ranges and Archery Range
- 3.2.1** On arrival, unlock the main gate if secured and leave this gate unlocked while the range is in use.

- 3.2.2** To access the Clubhouse, unlock the alarm box and turn off the alarm before unlocking and opening the clubhouse door.
- 3.2.3** Enter the following information in the Range Use Registry located at each range:
- a) date.
  - b) membership number and number of guests.
  - c) type of firearm (see code at top of registry page).
  - d) time in and time out.
  - e) for the Indoor Range and Pinecone Ranges, the number of rounds fired.

### **Security – Upper Ranges**

- 3.3** The upper ranges include the Pinecone Rifle Range and the Pinecone Multi-Use Range.
- 3.3.1** On arrival, unlock the main gate and immediately lock this gate behind you.
- 3.3.2** Complete the range use registry in the same manner as in 3.2.3 above.
- 3.3.3** On departure, unlock the main gate and immediately lock this gate behind you, even if the range is still in use.

## **PART 4 – SPECIAL EVENTS**

- 4.1** The club may host special events and the Board may implement specific rules intended to govern each special event. At the Board's discretion, they may suspend specific rules to allow an event to proceed.
- 4.2** All special events require the approval of the Board.
- 4.3** The use of Tannerite or other binary explosives is permitted only at special events and only with the prior approval of the Board.

## **PART 5 – FIREARM TRAINING POLICY**

- 5.1** Only the following club members are authorized to conduct firearms training at Club shooting ranges:
- a) Certified Firearms Instructor/Examiner as certified by the BC Chief Firearms Officer.
  - b) Certified C.O.R.E. Instructor/Examiner as certified by the BC

Wildlife Federation, for C.O.R.E. instruction only.

- c) Qualified Military or Police Firearms Instructor/Range Safety Officer, as qualified by the Canadian Armed Forces or a municipal, provincial, or federal police force.

- 5.2** The Board has sole discretionary authority to decide who may conduct firearms training at Club shooting ranges.

## **PART 6 – RECREATIONAL VEHICLE POLICY**

- 6.1** For members and their guests, recreational vehicles (i.e. motorhomes, towables, truck campers etc.) are permitted on Club property and at the Pinecone Ranges for special events and for camping for up to a maximum of seven nights. The length of stay may be extended with the written approval of the Board.
- 6.2** Recreational and other types of vehicles, including trailers and boats, cannot be stored on Club property or at the Pinecone ranges.
- 6.3** Club liability insurance does not cover recreational vehicles while on Club property or at the Pinecone ranges
- 6.4** All recreational vehicles must have valid licence and insurance while on Club property or at the Pinecone range.

## **PART 7 – RANGE OPERATION AND SAFETY**

### **Range flag system**

- 7.1** Each range has its own flag system, independent of other ranges. The flag system is the same for all ranges except the indoor range. This flag system is as follows:
  - a) A “range flag” which is very visible as you approach a range. A red flag means the range is in use. A green flag means that there is no one currently using that range.
  - b) A “firing line flag” which is visible once you are on the range. A red flag means that the range is “hot” and shooting is taking place. A green flag means the range is “safe” and no shooting is taking place.
- 7.1.1** The indoor range uses a light system instead of flags. There is only a firing line light, no range light. A red light is range “hot” and a green light is “safe”. The following uses the firing line flags in explanation; the use of the lights is the same procedure as the firing line flags system.

### **Firing line and area markings**

- 7.2** The red line just back from the firing line benches or stands outlines an

area where;

- a) During a red firing line flag (range hot), you may cross over the red line into the firing area.
- b) During a green firing line flag (range safe), you **MUST NOT** cross the red line into the firing line area. Under a green flag, there is no handling of firearms or accessories anywhere on the range.
- c) The exit(s) from the firing line out to the target area have two lines, a red line and a green line. When the red firing line flag is up, the red line is in operation. When the green firing line flag is up, the green line is in operation and you may cross it to access the target area.

### **Firearm handling**

- 7.3** Firearms that must be cased for transport as per the Firearms Act must be cased when arriving at any Club range. Firearms that are permitted to travel uncased may arrive as such at any Club range.
- 7.3.1** Cased firearms may be brought onto a range on either a red or green firing line flag. They can only be uncased on a red firing line flag.
- 7.3.2** Uncased firearms may only be brought onto a range under a red firing line flag.
- 7.3.3** Firearms and ammunition may only be brought onto the firing line under a red firing line flag.
- 7.3.4** Filled magazines may be brought to the range. Magazines may be filled on the range and on/off the firing line, but only during a red firing line flag.

### **Holstered firearms**

- 7.4** Holstered firearms are only permitted on the following outdoor ranges:
- a) BC-424-R (25 metre Outdoor Range) and
  - b) BC-575-R (Pinecone Multi-use Range)
- 7.4.1** Holstered firearms must be unloaded when off the firing line. If applicable, magazines must be removed from the firearm. Cartridges can remain in ammunition belts.
- 7.4.2** Holstered firearms are prohibited on the Indoor Range.
- 7.4.3** Holstered firearms are prohibited on Club property, in the Clubhouse or the Pinecone property except as noted in 7.4 above.

### **Range Safety Officer**

- 7.5** There must be a Range Safety Officer (RSO) present whenever a range

is in use. Any member is authorized to act as a Range Safety Officer.

- 7.5.1** The RSO has the authority to require any person on the range to display their numbered tag as well as produce their club membership card for inspection.
- 7.5.2** If there is only one person using the range, they must act as RSO and comply with all of the rules and regulations. If there is more than one person using a range, one of them must act as RSO.
- 7.5.3** The RSO is responsible for the safe operation of the range. Their directions must be followed immediately without question, since there may be a serious situation unfolding with no time to fully explain it to those on the range. If there is any disagreement about their directions, follow the directions at the time, then bring the details to the attention of any Board member for resolution at a later date. Failing to follow the directions of the Range Safety Officer while the range is in operation may result in disciplinary action.
- 7.5.4** If, in the opinion of the RSO, a person's ability to safely be on a range is impaired by alcohol, legal or illegal drugs, cannabis, or other reasons, the RSO is authorized to immediately suspend that person from that, and any other, Club range for the day. The RSO's decision to suspend for the day is final.

### **Range operation**

- 7.6** The range cycles as per the following, starting with arriving on two green flags:
- a) Change the range flag from green to red to indicate the range is now in use.
  - b) Leave the firing line flag green, and proceed downrange to set your targets. Return to behind the red firing line.
  - c) Once it is determined that everyone has returned from downrange, close the gate and the RSO will change the firing line flag from green to red. The range is now hot, and you may position your firearms on the shooting station. Loading may proceed.
  - d) When you are ready, and have determined it is safe to do so, you may commence firing on your target. Specific rules about firing, targets, target holders etc are found in each range rule sheet.
  - e) If anyone on the range notices an unsafe condition they may call a CEASE FIRE. After the call, the RSO will take charge of the situation.
  - f) On hearing CEASE FIRE, stop firing immediately. Keep muzzle pointed downrange, remove your finger off the trigger, UNLOAD



and PROVE safe and install chamber flag. Place your firearm with action open, if applicable, on the shooting stand or rack and step back from the firing area behind the red line.

- g) The RSO may walk the firing line to satisfy themselves that the firearms on the line are safe.
- h) Once the RSO is satisfied that all the firearms are in a safe condition, he will change the firing line flag from red to green, at which time you may open the gate and proceed downrange to deal with your targets.
- i) The cycle repeats starting with item c above.

### **Important points to remember**

**7.7** Please keep the following rules in mind when on the range:

- a) Proper eye and ear protection are mandatory on all ranges for both shooters and spectators.
- b) Load and unload firearms only on the firing line on a red flag.
- c) Fill magazines only on a red firing line flag.
- d) When moving a firearm to and from the firing line, keep the muzzle pointed up.
- e) Do not handle any firearms during a CEASE FIRE or while the green flag is up and the range is safe. This includes firearms that are not on the firing line.
- f) Stay out of the firing area, behind the red line while the range is SAFE and while shooters are downrange.
- g) Do not touch another person's firearm without permission.
- h) Remove used targets.
- i) Pick up empty casings.
- j) Dispose of fail-to-fire ammunition in the bin provided.
- k) Cross draw and fast draw are prohibited.
- l) Except at the Pinecone ranges and at special events, rapid fire is prohibited.
- m) Unsheltered metal targets are prohibited on the Pinecone Rifle Range.
- n) Shooting or target stand changes requires the approval of the Board.
- o) Consuming alcohol, or being under the influence of alcohol, while using a shooting range, is prohibited.

- p) Using cannabis or cannabis products or being under the influence of cannabis or cannabis products, while using a shooting range, is prohibited.
- q) The use of illegal drugs on Club property or at the Pinecone ranges is prohibited.
- r) All bullets must terminate into a bullet trap.
- s) Be polite, courteous and respectful of other shooters.

**PART 8 – 15 METRE INDOOR RANGE**

1. **Number of Targets:** 6
  2. **Firing Distance:** variable, up to 15 metres
  3. **Recommended Minimum Engagement Distance:** 3 metres
  4. **Approved Firearms:** air guns, rimfire rifles and handguns, centerfire handguns
  5. **Prohibited Firearms:** centerfire rifles, shotguns
  6. **Maximum Approved Calibre:** .500 S&W
  7. **Approved Ammunition:** jacketed, non-jacketed
  8. **Prohibited Ammunition:** steel jacketed, steel core, bimetal, armour piercing, incendiary, explosive, tracer
  9. **Approved Targets:** 11" x 17" paper only
  10. **Prohibited Targets:** all except as described under "Approved Targets"
  11. **Permitted Arcs of Fire:** all bullets must terminate in the bullet trap
  12. **Range Status Indicators:** red LIVE and green SAFE lights
- A. Protect your eyes and ears.
  - B. All firearms must be cased when entering or leaving the range.
  - C. When carrying firearms to/from the firing line, point the muzzle at the ceiling.
  - D. Only one firearm at a time at each shooting booth.
  - E. When shooting bench rest, use two target hangers to lower the target to the correct shooting height.
  - F. Advance forward of the firing line only during cleanup and only if:
    - 1) all firearms are removed from the firing line;
    - 2) all ammunition is removed from the firing line; and
    - 3) the range SAFE light is on.
  - G. Load firearms and magazines only at the firing line on a LIVE light.
  - H. No holstered firearms.
  - I. No rapid fire (minimum 3 seconds between shots).
  - J. No timed shooting i.e. MIL/TAC, CAS, IPSC, IDPA.
  - K. Remove used targets.
  - L. Pick up and dispose of empty casings and fail-to-fire ammunition in the bins provided.
  - M. Sweep up any burnt and unburnt powder from the range floor.
  - N. Do not fire centerfire handguns on lanes #1 and #6 unless lanes #2 - #5 are in use.
  - O. The bench top in lane #6 must be in the down position while the range is LIVE.
  - P. Place the ventilation on high when shooting centerfire handguns.
  - Q. Do not remove targets from this range for use on other ranges.
  - R. No human silhouette targets. Zombie targets are permitted.

**PART 9 – 25 METRE OUTDOOR RANGE**

1. **Hours of Operation:** 12:00 PM – 4:00 PM (Mon, Tue, Thu, Fri, Sat)  
2:00 PM – 4:00 PM (Wed, Sun)
  2. **Number of Targets:** 6
  3. **Firing Distance:** variable, up to 25 metres
  4. **Recommended Minimum Engagement Distance:** 10 metres
  5. **Approved Firearms:** air rifles/handguns, rimfire rifles/handguns, centerfire handguns (see item 6)
  6. **Approved Calibers:** .177, .17, .22, 9 mm, .40 S&W, .380 ACP, .45 ACP, .38 Special, .44 Special, .45 Colt
  7. **Prohibited Firearms:** centerfire rifles, shotguns, centerfire handguns (see item 8)
  8. **Prohibited Calibers:** 10 mm, .357 Magnum, .44 Magnum, .454 Casull, .460 S&W, .500 S&W, centerfire rifles, shotguns  
  
*\*These centerfire handgun calibers may be used at the Pinecone Multi-Use Range*
  9. **Approved Ammunition:** jacketed, non-jacketed
  10. **Prohibited Ammunition:** steel jacketed, steel core, bimetal, armour piercing, incendiary, explosive, tracer
  11. **Approved Targets:** paper, cardboard, balloons
  12. **Prohibited Targets:** human form or likeness (except zombie targets), plastic containers, glass, metal cans, steel reactives, clay pigeons
  13. **Permitted Arcs of Fire:** all bullets must terminate in the bullet trap
  14. **Range Status Indicators:** Range Flag: Red/Green  
Firing Line Flag: Red/Green
- A. Protect your eyes and ears.
  - B. Do not handle firearms when targets are being posted, checked, replaced or removed.
  - C. Do not fasten targets to, or hang targets from, the wooden target support framework.
  - D. Do not fire at objects placed on the retaining wall or wooden target support framework.
  - E. Do not fire at signs.
  - F. Remove used targets and pick up empty casings.
  - G. Do not use the flag system on the 88-metre range (no flag flying) when this range is in use.
  - H. The trap & skeet range has priority over the 88/25-metre range on Wednesdays & Sundays, 12:00 PM – 2:00 PM.
  - I. The 25-metre range has priority over the 88-metre range on Sundays, 2:00 PM – 4:00 PM.
  - J. Archery is prohibited on the 88/25-metre range.
  - K. No human silhouette targets. Zombie targets are permitted.

## PART 10 – 88 METRE OUTDOOR RANGE

1. **Hours of Operation:** 12:00 PM – 4:00 PM (Mon, Tue, Thu, Fri, Sat)  
2:00 PM – 4:00 PM (Wed, Sun)
  2. **Number of Targets:** 6
  3. **Firing Distance:** 88 metres
  4. **Recommended Minimum Engagement Distance:** n/a
  5. **Approved Firearms:** air rifles/handguns, rimfire rifles/handguns, centerfire handguns (see item 6)
  6. **Approved Calibers:** .177, .17, .22, 9 mm, .40 S&W, .380 ACP, .45 ACP, .38 Special, .44 Special, .45 Colt
  7. **Prohibited Firearms:** centerfire rifles, shotguns, centerfire handguns (see item 8)
  8. **Prohibited Calibers:** 10 mm, .357 Magnum, .44 Magnum, .454 Casull, .460 S&W, .500 S&W, centerfire rifles, shotguns  
*\*These centerfire handgun calibers may be used at the Pinecone Multi-Use Range*
  9. **Approved Ammunition:** jacketed, non-jacketed
  10. **Prohibited Ammunition:** steel jacketed, steel core, bimetal, armour piercing, incendiary, explosive, tracer
  11. **Approved Targets:** paper, cardboard, balloons
  12. **Prohibited Targets:** human form or likeness (except zombie targets), plastic containers, glass, metal cans, steel reactives, clay pigeons
  13. **Permitted Arcs of Fire:** all bullets must terminate in the bullet trap
  14. **Range Status Indicators:** Range Flag: Red/Green Firing  
Line Flag: Red/Green
- A. Protect your eyes and ears.
  - B. Do not handle firearms when targets are being posted, checked, replaced or removed.
  - C. Do not fasten targets to, or hang targets from, the wooden target support framework.
  - D. Do not fire at objects placed on the retaining wall or wooden target support framework.
  - E. Do not fire at signs.
  - F. Remove used targets and pick up empty casings.
  - G. Do not use flag system on the 25-metre range (no flag flying) when this range is in use.
  - H. The trap & skeet range has priority over the 88/25-metre range on Wednesdays & Sundays, 12:00 PM – 2:00 PM.
  - I. The 25-metre range has priority over the 88-metre range on Sundays, 2:00 PM – 4:00 PM.
  - J. Archery is prohibited on the 88/25-metre range.
  - K. No human silhouette targets. Zombie targets are permitted.

**PART 11 – TRAP AND SKEET RANGE**

1. **Number of Targets:** variable
  2. **Firing Distance:** variable
  3. **Recommended Minimum Engagement Distance:** n/a
  4. **Approved Firearms:** shotguns
  5. **Prohibited Firearms:** all firearms except shotguns
  6. **Maximum Approved Calibre:** 10 gauge
  7. **Approved Ammunition:** 7 ½ - 9 shot sizes
  8. **Prohibited Ammunition:** all except as described under "Approved Ammunition"
  9. **Approved Targets:** clay pigeons
  10. **Prohibited Targets:** all except clay pigeons
  11. **Permitted Arcs of Fire:** within the boundaries of the Skeet and Trap ranges
  12. **Range Status Indicators:** Range Flag: Red/Green  
Firing Line Flag: Red/Green
- A. Protect your eyes and ears.
  - B. Point your gun downrange when loading.
  - C. Load only at your firing position.
  - D. Semi-automatic and pump action shotguns must have their action open at all times when not on the firing line.
  - E. Break action shotguns must be broken open at all times when not on the firing line except when placed on the shotgun rack with the barrel pointing upwards.
  - F. Chamber flags are not used on shotguns at the trap/skeet range.
  - G. Action open until your turn to fire and when carrying from rack.
  - H. Muzzle pointed skyward when moving to and from the firing line.
  - I. Both upper and lower Trap machines may be used at the same time.
  - J. If the Skeet Range is in use, the lower Trap Range cannot be used.
  - K. If the Skeet or Trap ranges are in use, the Archery Range cannot be used. If the Archery Range is in use, the Skeet and Trap ranges cannot be used.

**PART 12 – ARCHERY RANGE**

1. **Number of Targets:** Variable
  2. **Firing Distance:** variable, up to 50 metres
  3. **Recommended Minimum Engagement Distance:** 10 metres
  4. **Approved Bows:** long, compound, recurve, cross  
**Approved Arrows/Tips:** target point, field point, broadhead
  5. **Prohibited Bows:** n/a
  6. **Maximum Approved Calibre:** n/a
  7. **Approved Ammunition:** n/a
  8. **Prohibited Ammunition:** n/a
  9. **Approved Targets:** foam, block, paper
  10. **Prohibited Targets:** all except as described under "Approved targets"
  11. **Permitted Arcs of Fire:** all arrows must terminate within the area of the backstop.
  12. **Range Status Indicators:** Range Flag: Red/Green  
Firing Line Flag: Red/Green
- A. Protect your eyes.
  - B. On HOLD, unnock your arrow and await further instruction.
  - C. Nock arrows on the shooting line only.
  - D. Point arrows in the direction of the target area only.
  - E. When pulling out arrows from the target, stand to one side and make sure no one is behind you.
  - F. Do not pick up arrows from behind the backstop unless a guard remains in front of the target area.
  - G. Do not use the Archery Range if the Skeet and Trap ranges are in use.
  - H. No human silhouette targets. Zombie targets are permitted.
  - I. Do not take archery targets from this range to the Pinecone.

**PART 13 – PINECONE RIFLE RANGE**

1. **Firing Points/Targets:** 12 firing points/5 targets per firing point
2. **Firing Distances:** 25m, 50m, 100m, 200m, 300m
3. **Recommended Minimum Engagement Distance:** 25m
4. **Approved Firearms:** air, rimfire, centerfire rifles
5. **Prohibited Firearms:** handguns and shotguns  
(use the handgun/shotgun range)
6. **Maximum Approved Calibre:** up to & including .50 calibre
7. **Approved Ammunition:** jacketed, non-jacketed
8. **Prohibited Ammunition:** armour piercing, incendiary, explosive, tracer
9. **Approved Targets:** paper, cardboard, balloons; sheltered metal
10. **Prohibited Targets:** Human form or likeness (except Zombie targets), plastic containers, glass, metal cans, unsheltered metal targets, clay pigeons
11. **Permitted Arcs of Fire:** all bullets must terminate in the bullet trap
12. **Range Status Indicators:** Range Flag: Red/Green  
Firing Line Flag: Red/Green

- A. Protect your eyes and ears.
- B. Do not handle firearms when targets are being posted, checked, replaced or removed.
- C. Follow the posted procedure to advance forward of the firing line.
- D. Stay behind the firing line when the range is SAFE.
- E. Do not advance forward of the firing line to shoot.
- F. Do not fasten targets to, or hang targets from, the wooden target support framework.
- G. Do not fire at objects placed on the wooden target support framework.
- H. Do not fire at objects placed on top of the bullet trap.
- I. Do not fire into the left or right flank extension area.
- J. Do not fire at signs.
- K. Remove used targets and pick up empty casings.
- L. Dispose of fail-to-fire ammunition in the bin provided.
- M. Follow the firing line flag system when posting, checking, replacing or removing targets. You cannot be seen from the firing line if you advance past the 200m bullet trap.
- N. No human silhouette targets. Zombie targets are permitted.
- O. Unsheltered metal targets are prohibited.



**PART 14 – PINECONE MULTI-USE RANGE – STANDARD TARGETS**

(Please see Part 15 for steel target use)

1. **Firing Points/Targets:** fixed firing line; variable target positions
  2. **Firing Distances:** variable, up to 25 metres
